What follows are some important things you should know before you submit this application: Credit cards are required for accounts shipping less than \$150 per quarter and for accounts sixty days past due. Accounts billing more than \$150 per week are invoiced on a weekly basis. Accounts billing less than \$150 per week and accounts being billed on a credit card are invoiced on a biweekly basis. Any account thirty days past due will incur interest and collection agency fees.
